Payment

5. The Operator agrees to accept liability for payment of all landing fees at the rates set out above.
6. Pre-payment will be required for landings to those operators without credit arrangements with Professional Helicopter Services Pty Ltd.

NOTAM

6. The Operator acknowledges receipt of the NOTAM and operational procedures for helicopter flights to and from the Pramac Generac Australian Motorcycle Grand Prix event (as defined in the Act) on 25 - 27 October 2019 (**Event**). The Operator must ensure that all pilots operating the helicopters noted above are properly briefed, agree to and will comply with the NOTAM and operational procedures for all flights to and from the Phillip Island Grand Prix Circuit.

Relocation of helicopter

7. The Operator hereby authorises the Organisers or any of them to relocate, or procure the relocation of, any of the above mentioned helicopters or any other equipment belonging to the Operator at any time if, in the opinion of the Organisers, the helicopter or equipment is interfering with the conduct of any part of the Event.

Insurance

8. The Operator agrees to take out the insurance detailed in the attached Aviation Insurance Declaration Form and will ensure that its insurance company, agent or broker provides a completed form to Mr Ben Hall, Professional Helicopter Services Pty. Ltd., Bundora Parade, Moorabbin Airport email: operations@pfs.com.au) by 21 October 2019.

Release and indemnity

9. The Operator acknowledges and accepts that motor racing and related activities are dangerous and accidents can happen, and that entry to and remaining at the Event has a degree of danger. To the extent permitted by law, the Operator and each of its pilots, employees, agents, sub-contractors, consultants (including employees of those agents, sub-contractors and consultants), directors, officers and sub-licensees (and anyone acting on behalf of or at any of their direction) (**Personnel**) excludes, releases and forever discharges each of the Organisers from all liability for claims, loss, damage, costs or expenses (whether arising under statute, from negligence, personal injury, death, property damage, infringement of third party rights or otherwise) arising from or in connection with the Event or the helicopter operations.

10. The Operator acknowledges and agrees that none of the Organisers will be responsible for acts, omissions or defaults of the Operator or its Personnel nor, to the extent permitted by law, will any Organiser be liable for any claim, loss, damage, cost or expense (whether arising under statute, from negligence, personal injury, death, property damage or infringement of third party rights or otherwise) arising from any act, matter or thing done, or permitted or omitted to be done, by the Operator or its Personnel pursuant to or in connection with the Event or the helicopter operations.

11. The Operator indemnifies and must keep indemnified each of the Organisers and their respective personnel (including employees, agents, sub-contractors, consultants, directors, officers, sub-licensees marshalls, rescue and medical staff, competitors and volunteers (**Organiser Personnel**)) against all such claims, loss, liability, damage, cost or expense which may be incurred or sustained by any of the Organisers or the Organiser Personnel arising from any act, matter or thing done, permitted or omitted to be done by the Operator or its Personnel pursuant to, in default of or in connection with the Event or the helicopter operations.

To register to land your helicopter within the Phillip Island Grand Prix Circuit (as defined in the *Australian Grands Prix Act 1994* (Vic)) at the Pramac Generac Australian Motorcycle Grand Prix, you must arrange an aviation hull and liability policy that incorporates public liability (including personal injury and death and passenger liability and flight, taxiing and ground aviation risks) and property damage (including your own and any third party property). The public liability and aviation cover must be for a minimum of \$20 million (for each occurrence) and property damage cover must be for full replacement value. The policies must contain a cross liability clause and name the Operator and each of the parties below as joint insureds. The Operator will be liable for all premiums and excesses payable in relation to any insurance cover affected and shall further be responsible for any loss, damage, injury or other occurrence which falls outside the scope of the cover provided by the policies.

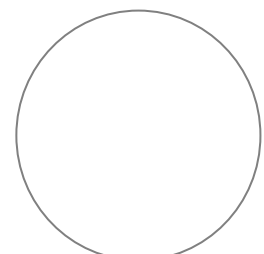
