

CONDITIONS OF ENTRY TO CAMPING GROUNDS

PHILLIP ISLAND GRAND PRIX CIRCUIT

Entry to and presence at the camping grounds (**Camping Grounds**) for the MotoGP™ Grand Prix of Australia 2026 (**Event**) by any person (**Patron**) is subject to the following Australian Grand Prix Corporation (**AGPC**) Camping Grounds conditions which shall be read in addition to the Attendance Conditions available at www.motogp.com.au (including, without limitation, the release contained in Attendance Conditions 3 - 4 for the Event) (together the **Conditions of Entry to Camping Grounds**). By entering the Camping Grounds, Patrons are deemed to have accepted and understood as binding on them, all of these Conditions of Entry to Camping Grounds and any accompanying risks, obligations and responsibilities.

Entry

1. In order for a Patron to gain entry to the Camping Grounds, the Patron must purchase a ticket to the Camping Grounds (**Campground Ticket**) prior to arriving at the Circuit and display a colour coded non-transferable wristband (**Campground Wristband**). Each Patron must purchase a Campground Wristband prior to the Event (through the “person add on” function when purchasing a Campground Ticket via www.motogp.com.au), which will be mailed out. Campground Wristbands purchased within 45 days of the Event will not be mailed out and must be collected from the Campground Ticketing Office. Note that the Campground Wristband does not grant the Patron access to the Phillip Island Grand Prix Circuit (**Circuit**) and a valid ticket must be purchased as a requirement for Circuit entry.
2. In order for any registered passenger car (**Vehicle**) to gain entry to the Camping Grounds, the Vehicle must display a colour coded vehicle campground permit affixed to the passenger side of the Vehicle windscreen (**Vehicle Campground Permit**). Vehicle Campground Permits are purchased prior to the Event (via www.motogp.com.au) and will be mailed out when purchasing a Campground Ticket. Vehicle Campground Permits purchased within 45 days of the Event will not be mailed out and must be collected from the Campground Ticketing Office. Each Patron within the Vehicle must have a Campground Wristband. Note that the Vehicle Campground Permit does not grant access to the Circuit and a valid ticket must be provided as a requirement for Circuit entry.
3. Where a Campground Ticket allocates a Patron to a particular site within the Camping Grounds (**Campsite**), a Patron must only camp within that allocated Campsite as directed on the Campground Ticket. If a Patron camps outside of their allocated Campsite, the Patron will be required to move their belongings to within their allocated Campsite.
4. Patrons may bring the following items into the Camping Grounds:

- a. subject to Condition 16 below, tents, marquees and other temporary structures used solely for camping purposes (**Tents**);
 - b. subject to Condition 17 below, barbeques;
 - c. a Vehicle or motorcycle, subject to the following conditions:
 - i. **Highside North and Highside South camping areas:** one Vehicle and/or motorcycle/s per Campsite, provided that they fit within the designated Campsite boundary. Overflow parking and additional vehicle access are available to be purchased online;
 - ii. **Trackside camping area:**
 - only those in powered Campsites are permitted to park one campervan at their Campsite;
 - all other Campsites (except Pre-Pitched Campsites) only permit one car and/or multiple motorcycles, however they must fit within their designated Campsite boundary; and
 - Pre-Pitched Campsites do not include parking located within their Campsite. Vehicles have 30 minutes to unload and then are required to park in the overflow car park located approximately 400 metres from the Pre-Pitched Campsites;
 - iii. **Glamping area:** glamping campers have an exclusive car park located next to the Glamping area. Each Campsite provides access for one car and/or multiple motorcycles within the Glamping car park. Overflow parking and additional vehicle access are available to be purchased online;
 - iv. multiple motorcycles are permitted per Campsite, however they must fit within their designated Campsite boundary;
 - v. in Trackside Campground, should a vehicle be required to move from their Campsite after dark, campground security must be informed to provide an escort. We ask for your cooperation in keeping our Camping Grounds safe; and
 - vi. Vehicles and motorcycles are not permitted to cross the Go-Kart track in the Trackside camping area at any time, except for at the designated crossing points;
 - d. subject to Condition 18 below, generators;
 - e. subject to Condition 19 below, gas bottles; and
 - f. firewood for personal use only, provided that each piece of firewood is pre-split and is no longer than 500 millimetres in length and the total amount of firewood per Patron does not occupy an area of greater than 1 square metre.
5. The Patron acknowledges and agrees that they are responsible for their own property and, to the maximum extent permitted by law, AGPC will not be liable for any loss or damage to any property brought into the Event (which includes the Camping Grounds).

6. An AGPC representative or any third-party contractor (in its absolute discretion) can refuse the service of alcohol to any Patron in accordance with its responsible service of alcohol obligations under the *Liquor Control Reform Act 1998* (Vic).

Prohibited items

7. Without limiting any provision of the *Major Events Act 2009* (Vic), Patrons must not, without the prior written consent of AGPC, have in their possession in the Camping Grounds, or bring into the Camping Grounds, any of the following items:
- a. illegal substances;
 - b. alcoholic beverages (unless purchased at the Event);
 - c. glass bottles or containers (except glass jars containing 300 grams or under of vegemite, jams or food preservatives);
 - d. beverage containers with the manufacturer's seal broken (unless purchased at the Event). All liquids contained in reusable beverage containers (with the manufacturer's seal broken) must be surrendered upon entry. Patrons may dispose of or empty their bottles before entering the Camping Grounds;
 - e. clothing bearing any racist, indecent or obscene language or images, or clothing that is intimidating to other Patrons such as outlaw motorcycle club colours;
 - f. prohibited or controlled weapons or firearms within the meaning of the *Control of Weapons Act 1990* (Vic) or any dangerous goods;
 - g. animals other than animals recognised as assistance animals under the *Disability Discrimination Act 1992* (Cth). AGPC, acting reasonably, may at any time request evidence that such animal is an assistance animal, and/or the animal is trained to meet standards of hygiene and behaviour that are appropriate for an animal in a public place;
 - h. items, including any metal flag or banner pole, any extendable flag or banner pole longer than 1 metre, or any flag or banner, used or to be used in contravention of Condition 8(t);
 - i. whistle, loud hailer, public address system, electronic or other broadcast device or any other device which may interfere with electronic or radio communications or broadcasting signals and equipment used by AGPC, or other persons authorised by AGPC, in connection with the Event;
 - j. flares, fireworks, laser pointers or other distress signals;
 - k. public address system, electronic equipment, broadcast equipment or similar device which may interfere with broadcast equipment or similar device being used by AGPC or other persons authorised by AGPC in connection with the Event;
 - l. vehicles, including any golf buggy, bicycle, skateboard, roller skates, roller blades, e-scooter or scooter (unless reasonably required to facilitate access to the Event for a person with a disability, health condition or impairment);

- m. items or possessions of which does not have an ordinary and reasonable use by a Patron at the Event and which may be used to damage or deface property, buildings or any part of the area used for the Event (including without limitation any spray paint), disrupt or interrupt the Event, hinder, obstruct or interfere with any rider or driver taking part in the Event, adversely affect public safety, excavate any part of the area used for the Event or erect any structure;
- n. items that the Patron intends (or such quantities of the item from which AGPC can reasonably infer that the Patron intends) to distribute, hawk, sell, offer or expose for sale;
- o. unmanned aerial vehicles, drone or unmanned aircrafts, spider cameras or any other aerial photographic, video or audio recording equipment;
- p. camera lenses with a physical length greater than 300 millimetres or any other item which might reasonably obstruct the view of any other Patron;
- q. photographic, video or audio recording equipment which AGPC reasonably considers may be used for commercial purposes, and may include (without limitation) audio recorders, camera tripods, monopods or any digital recording equipment; or
- r. political, religious or offensive items such as, but not limited to, flags, clothing, banners, signs and symbols which may be used for a political or religious protest, or for any racial, discriminatory or offensive purpose.

Prohibited conduct

- 8. Patrons must not (without the express consent of AGPC):
 - a. enter any fenced or cordoned off area, or interfere with any activity undertaken by AGPC in any fenced or cordoned off area, including but not limited to the racetrack and marshal zones;
 - b. enter or remain, or cause any person to enter or remain, in the lake or waterway within the Camping Grounds;
 - c. remain at the Camping Grounds or any area used for the Event outside the published gate open times of the Event;
 - d. leave the Event other than through a designated exit;
 - e. remove any glass object from a reserved area;
 - f. block any thoroughfare or erect any structure;
 - g. litter or misuse, deface, damage, or tamper with any building or thing;
 - h. pick any flowers, damage or uproot any tree, shrub, or other plant or flora, or disturb or interfere with any fauna, or excavate any part of the Camping Grounds;
 - i. climb, attempt to climb or remain on any tree or structure;
 - j. post, stick, place or attempt to post any poster, placard, bill, banner, print, paper or any advertising material on any building, structure, fence or tree;

- k. distribute any printed or visual matter, promote any advertising or promotional material, samples of goods or services or any other matter or thing or otherwise engage in ambush marketing;
- l. distribute, hawk, sell, offer or expose for sale any goods or services or collect money or orders from Patrons for goods and services;
- m. operate or use a loud hailer, public address system or other device which may interfere with electronic or radio communications being used by AGPC;
- n. throw or kick any stone, bottle or other projectile;
- o. busk or conduct similar entertainment;
- p. conduct public surveys or opinion polls, solicit money, donations or subscriptions from members of the public;
- q. sell, offer or make available for sale, or give away any Campground Ticket, including but not limited to selling a Campground Ticket or Campsite on third party websites such as AirBnB;
- r. disrupt, interrupt or behave in any manner that may disrupt or interrupt any official or employee or contractor of AGPC, or any race, event or activity;
- s. act or conduct oneself in such a way as to hinder, obstruct or interfere with a rider or driver of any vehicle taking part in a race or to adversely affect the safety of the public;
- t. deliberately obstruct the view of any Patron seated in a seat in the immediate vicinity, or cause unreasonable inconvenience to any Patron, official or employee or contractor of AGPC, or interfere with the comfort of any Patron or their enjoyment of the Event;
- u. use racist, indecent or obscene language or threatening or insulting words or otherwise behave in a threatening, abusive, riotous, indecent or insulting manner;
- v. interfere with, obstruct or hinder AGPC or an Authorised Person in the exercise of their powers, functions or duties;
- w. ignite any flare or firework, explosive or smoke bomb;
- x. become intoxicated, use banned drugs or supply alcohol to minors;
- y. smoke in a designated 'no smoking' area;
- z. wear motorcycle helmets while inside the Camping Grounds. Patrons must remove their helmets upon entry and store them appropriately;
- aa. refuse to follow any direction issued by AGPC and/or an Authorised Person;
- bb. urinate or defecate otherwise than in a toilet facility provided by AGPC;
- cc. make excessive loud noise at all times, ensuring that there is no loud music or other loud activities conducted between the hours of 10:00 pm and 7:00 am;
- dd. allow any fire to be or become out of control;

- ee. light any fire on a nominated Total Fire Ban day;
- ff. enter the race track (including but not limited to the marshal zones) or any other restricted area (including the dam or waterway) without the authorisation of AGPC;
- gg. enter or leave the Camping Grounds other than through a designated entrance/exit;
- hh. set up on or use another Campsite that is not the Patron's pre-allocated Campsite on the Patron's access pass;
- ii. exceed the allocated space of the Patron's purchased Campsite and/or encroach on another Campsite; or
- jj. leave Vehicle engines running while stationary in the Camping Grounds.

Breach

9. The Patron acknowledges that, without prejudice to, and without limiting, any other rights which AGPC or any Authorised Person may have, if the Patron contravenes any of these Conditions of Entry to Camping Grounds (in the reasonable opinion of AGPC and/or an Authorised Person) AGPC may in its absolute discretion:
- a. refuse the Patron entry to the Circuit and/or Camping Grounds for the Event, direct the Patron to leave the Circuit and/or Camping Grounds during the Event, cancel a Patron's Campground Ticket, require the Patron to surrender their Campground Wristband and/or prohibit the Patron from attending future Events;
 - b. require the Patron to surrender any object (including the prohibited items listed under Condition 7) brought into the Camping Grounds in contravention of these Conditions of Entry to Camping Grounds (including any vehicle or transportation device brought into or used within the Camping Grounds in contravention of these Conditions of Entry to Camping Grounds) to AGPC or an Authorised Person (**Confiscated Item**); and
 - c. take legal action against the Patron in connection with any contravention, including issuing a penalty under the *Major Events Act 2009* (Cth).

Authorised Person

10. AGPC or its representatives, or any person appointed as an authorised officer pursuant to the *Major Events Act 2009* (Vic) (**Authorised Person**) may, with reasonable cause, refuse entry to or direct any Patron to leave the Camping Grounds. Pursuant to the *Major Events Act 2009* (Vic), any Patron who has been directed to leave the Event (which includes the Camping Grounds) is prohibited from re-entering the Event for a period of 24 hours.
11. AGPC or an Authorised Person may, at any time, inspect any Vehicle, trailer, Tent or camping equipment, bag, basket or other receptacle or require a Patron to turn out their pockets, bag, basket or other receptacle.

12. Any consent given by AGPC or an Authorised Person may be revoked by AGPC or such Authorised Person at any time. If such consent is withdrawn, the Patron must immediately remove or hand to AGPC or an Authorised Person the offending article or immediately leave the Camping Grounds through the nearest exit.
13. Patrons must comply with all reasonable directions of AGPC or its agents and any Authorised Person.

Children

14. Children are eligible to camp at the Event for no cost, however they are required to wear a child's Camping Wristband, which will need to be collected from the Campground Ticketing Office prior to entering the Camping Grounds. A child is classified as anyone 14 years or under as at the time of the Event. AGPC reserves the right to make a reasonable assessment of a child's age for the purposes of determining their qualification for admission to the Event pursuant to a child's Camping Wristband, or otherwise, and AGPC's (or any of its representative's) assessment will be final and determinative. For the avoidance of doubt, AGPC (or its representatives) may refuse entry to any person claiming entitlement to a child's Camping Wristband referred to in this Condition whom they assess as not being qualified for any such child's Camping Wristband, and no refund will be claimable, however AGPC (or its representatives) may allow an upgrade at its (or their) discretion. Note that the child's Campground Wristband does not grant access to the Circuit and a valid ticket must be provided as a requirement for Circuit entry.
15. Patrons who bring children to the Camping Grounds are responsible for the care, conduct and supervision of those children at all times and must keep those children within sight at all times. Children may not be permitted to enter certain areas at the Event for safety reasons as determined by AGPC.

Tents/fires/generators/gas bottles

16. In respect of Tents brought into and used in the Camping Grounds, Patrons acknowledge and agree to the following:
 - a. no Tents may be erected which require occupancy permits;
 - b. no Tents may be erected prior to Camping Ground opening times (unless with the written authorisation of AGPC); and
 - c. Tents must be a reasonable size, must not exceed the dimensions of the allocated Campsite and must be erected by Patrons themselves (third parties such as personnel representing tent hire companies will not be permitted access).
17. In respect of campfires lit and barbeques used in the Camping Grounds, Patrons acknowledge and agree to the following:
 - a. campfires must only be lit in either a container that properly contains the fire or in a trench that is no greater than thirty cm deep. The size of the fire must not exceed 1 metre in diameter;

- b. all campfires must be kept at a reasonable and manageable size, and the ground and airspace within 3 metres of the fire must be clear;
 - c. an adult (over the age of 18 years) must be in attendance at all times whilst the barbeque or campfire is alight;
 - d. fires are not to be lit inside Tents or other structures; and
 - e. naked flames such as candles are not permitted within Tents or other structures.
18. Generators for personal use are permitted in the Camping Grounds, subject to the following:
- a. generators must not be operational between 10:00 pm and 7:00 am on any day;
 - b. an adult (over the age of 18 years) must be in attendance at all times when a generator is being run;
 - c. for each generator brought into the Camping Grounds by a Patron, that Patron must have at least 1 fire extinguisher;
 - d. generators must not have a capacity greater than 5 KvA output;
 - e. fuel for generators must be safely stored within a suitable sealed container, and not stored within a Tent. Refuelling is only permitted when the generator is turned off;
 - f. the maximum amount of fuel permitted to be brought into the Camping Ground, in addition to the tank on the generator itself is not to exceed 20 litres per generator; and
 - g. the ground and airspace within 500 millimetres of the generator must be clear.
19. Gas bottles for personal cooking use are permitted in the Camping Grounds, subject to the following:
- a. gas bottles must be free of rust and corrosion and must not contain any dents or other damage; and
 - b. gas bottles must be stamped in accordance with all relevant laws or regulations as evidence that they have been safety checked in the past 10 years.

Weather conditions

20. As the Event (including the camping) takes place outdoors, conditions of the Camping Grounds may vary (including access, protection from weather, terrain and available facilities). Some areas at the Event are exposed to direct sunlight, heat, high winds and extreme wet weather conditions (including mud).
21. The Patron acknowledges and agrees that:
- a. AGPC reserves the right to determine the actual and final location of the Patron's Campsite; and

- b. if AGPC (in its absolute discretion) deems that any area of the Camping Grounds is not safe for Patrons, that AGPC has the right to reallocate the Patron to another area of the Camping Grounds or cancel the Patron's Campground Ticket.

Pre-Pitched and Glamping Tents

22. These Conditions 22 – 27 apply to Patrons who have purchased a Tent that is pre-pitched (**Pre-Pitched Tent**), or a glamping Tent (**Glamping Tent**). For the purposes of these Conditions of Entry to Camping Grounds, Pre-Pitched Tents and Glamping Tents means AGPC erected tents, including all fixtures and chattels, within the Camping Grounds rented by a Patron for use during the Event.
23. Patrons acknowledge and agree that a Pre-Pitched Tent is a basic form of camping accommodation, and it is the sole responsibility of Patrons to make reasonable enquires as to the suitability of the Pre-Pitched Tent for the Patron's individual needs and requirements. AGPC will not reimburse any alternative accommodation arrangements made by the Patron.
24. Pre-Pitched and Glamping Tents Patrons must not:
 - a. use or operate any barbeque, open flame (including any campfire) or other cooking device in or near any Pre-Pitched Tent or Glamping Tent, other than in accordance with Condition 16;
 - b. use the Pre-Pitched Tent or Glamping Tent for any illegal purpose;
 - c. tamper with, repair or modify the Pre-Pitched Tent or Glamping Tent in any way;
or
 - d. use streamers, decorations, flags or any form of adhesive within or on the Pre-Pitched Tent or Glamping Tent.
25. Pre-Pitched Tent or Glamping Tent Patrons must keep and maintain the Tents and surrounding area in a clean and tidy condition during the Event.
26. A Pre-Pitched Tent or Glamping Tent must be returned to AGPC in the same condition it was provided to the Patron. If the Pre-Pitched Tent or Glamping Tent is not returned in a clean and tidy condition, to the reasonable satisfaction of AGPC, AGPC reserves the right to charge and the Patron agrees to pay, all excess cleaning fees.
27. Pre-Pitched Tent or Glamping Tent Patrons are responsible for all loss or damage to the Tent during the Event. If there is any issue with a Tent, the Patron must immediately notify staff located at the Camping Grounds' office.

Miscellaneous

28. The Patron acknowledges and agrees that their purchase of a Campground Ticket and entry to and presence at the Camping Grounds is subject to:
 - a. these Conditions of Entry to Camping Grounds;
 - b. the Attendance Conditions relating to the Event;

- c. any special conditions or requirements specified by AGPC or as displayed on the Campground Ticket or any other ticket;
 - d. Part 4 and Part 9A of the *Major Events Act 2009* (Vic);
 - e. Part 3A and Part 4 of the *Australian Grands Prix Act 1994* (Vic); and
 - f. any directions issued by AGPC, which includes its representatives and any person appointed as an Authorised Person.
29. The Patron acknowledges and agrees that any part or parts of these Conditions of Entry to the Camping Grounds which contravene the law of the relevant jurisdiction and are not enforceable (or part or parts thereof) are severable and do not invalidate the remaining conditions.
30. AGPC reserves the right to amend these Conditions of Entry to the Camping Grounds from time to time and will include the amended Conditions of Entry to the Camping Grounds at www.motogp.com.au. Where any amendment of these Conditions of Entry to the Camping Grounds is material and will detrimentally impact the Patron, AGPC will notify the Patron of this amendment.
31. The parties agrees that these Conditions of Entry to the Camping Grounds will be governed by and construed in accordance with the laws of the State of Victoria and the parties submit to the exclusive jurisdiction of the courts of the State of Victoria.
